4. NHS England Update - Angela Wood

Angela covered several update areas, including ETTF bids, EPMA bids, GP WiFi, Care Homes Bed Availability, ERS, and 111 Online. There were a number of questions. Angela confirmed that NHS-E updates would continue at NYHDIF in future.

5. NHS Digital Update - Harjit Sembhi

Harjit gave a Cyber update, and covered several associated areas. She also updated on an imminent circular concerning suppliers, and another concerning credit management.

6. Information Governance Sub-Group – Sue Meakin

Sue mentioned three main areas: the new Toolkit, the Information Sharing Gateway, and the Information Governance Alliance

7. ISD Network Update - Heather Cook
