# SUMMARY MINUTES OF A VIRTUAL MEETING OF THE FORUM HELD ON FRIDAY 15 MAY 2020 USING MS-TEAMS

#### 1. Welcome

The Chairman, Heather Cook (Mid Yorks NHST), welcomed all members present on the Teams meeting. A full list of recorded attenders is at Appendix 1. A total of 47 members were recorded as having attended, in full or in part. It was noted that there was no formal agenda for this meeting, but most of the items to be discussed were self-evidently-included.

# 2. Apologies

No apologies were recorded as having been received.

### 3. Minutes of Last Meeting

#### 3.1 Accuracy

The minutes of the previous meeting on Friday 13<sup>th</sup> March 2020 were agreed as a true and accurate record.

#### 3.2 Matters Arising

There were no matters arising.

#### 4. NHS-E Covid-19 Update - Paul Rice

Paul gave a very useful, comprehensive update in several current areas of interest and activity, all of which generated a number of questions and discussions, featuring, in particular, money, and care homes. Heather suggested setting up a small group within NYHDIF to examine the issues associated with care homes, which was generally supported. **ACTION – Heather to initiate setting up this Care Homes group.** Paul also mentioned, significantly, that Zoom was at least as good as MS-Teams, provided it was set up and used correctly and securely.

# 5. Setting up NHS Nightingale, Harrogate – Cindy Fedell

Cindy gave an excellent, informative, and very impressive presentation about the high-speed setting up of this facility, including the use of ROC drills (Rehearsal of Concept practices). #### 6. NHS England Update - Dean Davidson

A brief update covering several important areas, especially Covid-19 response.

#### 7. NHS England Update – Angela Wood

Angela covered several areas, including, GPs' new requirements, hot hubs, EPS, funding, and several other areas, nearly all Covid-19-related.

# 8. NHS Digital Update - Harjit Sembhi

Harjit covered several areas, including N365 and use of MS-Teams. Heather and several others expressed concern about the frequent difficulties getting into MS-Teams.

### 9. Information Sub-Group Update – Sue Meakin

Sue mentioned the Control of Patient Information (COPI) notice, issued under Regulation 3, facilitating Covid-19 patient identifiable data handling, but stressed that this was only temporary. It's about proportionality – recording risks, etc. James Rawlinson mentioned sharing a DPIA for the NHS-X Tracking App.

### 10. ISD Network Update - Nigel Booth

Nigel said that all events are available, and all are online until the end of June at least. He also mentioned that, significantly, nearly all the events use Zoom.

#### 11. AOB

Paul Nicholas raised a discussion about options for progress in a post-Covid-19 world. The discussion covered working from home (WfH) or on-site, or a combination. Also mentioned was the issue around tax liability/deductibles when home working. Following further discussion, also involving Heather, it was clear that a combined examination of this would be more efficient and worthwhile, and so it was **AGREED that Paul Nicholas would initiate setting up a NYHDIF-wide Working From Home Implications Group**.

12. Next Meeting: Friday 10th July 2020, starting at 9:30am, VIRTUAL, using MS-Teams; invitations to be issued via email by Heather about a week or so in advance.
