SUMMARY MINUTES OF A VIRTUAL MEETING OF THE FORUM HELD ON FRIDAY 11 SEPTEMBER 2020 USING MS-TEAMS

1. Welcome

The Chairman, Heather Cook (Mid Yorks NHST), welcomed all members present on the Teams meeting. A full list of attenders (full and part time) is appended at Appendix 1. A total of 33 members attended, in full or in part, together with 5 external speakers

2. Apologies

3. Minutes of Last Meeting

3.1 Accuracy

The minutes of the previous meeting on Friday 10th July 2020 were agreed as a true and accurate record, with two minor corrections. The date of the meeting in the Heading should read "10 July 2020", and in paragraph 4, ISD Update, the ACTION completion date should read "end of September 2020"

3.2 Matters Arising

There were no further matters arising from the minutes which were not covered by agenda items.

4. Options for Conference 2020 - James Rawlinson

James gave a summary of the options being considered by the Management Committee.

5. NHS-E Update

5.1 Angela Wood tabled an update from Dean Davidson for circulation (Secretary's note – done). She went on to discuss several different issues around funding involving both primary and secondary care services.

5.2 Paul Rice, speaking later but under this item, covered the numerous disparate activities being undertaken the Covid-19 requirements, as well as some issues around LHCR, Diversity, funding, etc. He also mentioned that, following Cindy Fedell's imminent departure from Bradford, he (Paul) would be taking over the role across Bradford, Airedale, etc. (Secretary's note – the precise date for this new start for Paul is 1st January 2021).

6. NHS-D Update - Harjit Sembhi

Harjit gave her usual comprehensive coverage of all relevant areas of activity within NHS-D, and tabled a paper for circulation to all members covering all relevant details. (Secretary's note – done).

7. Information Sub-Group Update – Sue Meakin

Sue covered several areas, including COPI notices, National Data Opt-out, IG Toolkit, EU exit, N365 (a hot topic generally), and NHSmail. There were a number of questions, once again several of which involved N365.

8. ISD Network - Caroline Booth

Caroline gave a useful update on the ISD Network – they were running as many courses as possible, mostly online; and the Learning Portal was proving very popular.

9. Local Health Care Records Exemplar – Lee Rickles

Lee said that progress had been satisfactory, including the data porting – details will be circulated to all members. He also gave a useful update on the Digital Academy activities, which seem to be progressing well.
