SUMMARY MINUTES OF A VIRTUAL MEETING OF THE FORUM Held on Friday 14th January 2022 using MS-Teams

1. Welcome

The chair, Heather Cook, welcomed members to the virtual meeting. A full list of attendees (full- and part-participants) is included as Annex 1. In all, 43 attended the January meeting.

2. Apologies

3. Minutes of September 2021 meeting and Matters Arising

These were accepted as an accurate record and no matters arising were raised. It was noted that the Forum held its annual conference between the September and January meetings.

4. **NHS England Update**

Angela Wood provided a verbal update for the Forum.

Front line digitalisation - All should be aware of their own organisational position regarding funding e.g., seed funding.

Cyber - There was a query re. Cyber revenue funding and a request from the Chair that NHS E finance copy in relevant CIOs, as CIOs are not always aware of approved bids. The Cyber bids are now closed (Tranche 5). **[ACTION: NHS E]**

Access to Elective recovery funding is available via ICS.

No information was available on a recent Community funding bid.

Next year there will be further streamlining of the Unified Tech Fund.

It was noted that Karen Payne has started work on Remote Monitoring and is keen to give an update at a future meeting. **[ACTION: NYHDIF SUPPORT]**

Angela is moving to a new Interim role and Vicki Linford is covering until 31 March 2022. Her new role relates to helping the digitisation of community health services.

The Group thanked AW for her contributions to NYHDIF.

6. **NHS Digital Update**

Unfortunately, Oliver Christie was unable to attend the meeting, however a written update has been circulated to members.

7. Information Governance Sub-Group Update - Susan Meakin

DSPT Improvement Plans are currently on hold. Organisational 'status' will roll-over unless some wish to submit a revised improvement plan.

Susan reviewed some of the possible 22/23 Toolkit changes.

Other updates and discussions covered: -

- Recent Sub-Group meeting items
- Early work on the IG implications of the CCG to ICB transition
- NIMS/ESR data recoding

8. **ISD Network Update – Caroline Booth**

The updates and discussions included: -

- Face-to-face sessions now converted to online
- Strategy day and conference
- Power Apps as a new (possibly chargeable) area for next year
- Business Analysis foundation exam chargeable at cost next year
- Exploring virtual classroom tools

9. Yorkshire & Humber Care Record Update (YHCR) – Lee Rickles

Significant progress continues to be made. Of note is HC&V where 3 Trusts, 3 Local Authorities and Primary Care are connected. Summary level information is being exchanged.

Use-cases are being worked on by YAS to cover 999,111, PTS.

The GP Connect connection is available and is easier to navigate than the SCR.

A number of onboarding discussions are taking place.

Next year is likely to include discussions re. care homes possibilities.

February remains the plan for TPP to provide non-HTML data.

10. **Review of NYHDIF Conference on 11th & 12th November 2021**

Ted Woodhouse reviewed the conference feedback.

35% of delegates responded to the feedback questionnaire.

Overall, the quality of the annual conference was assessed as being high. The variety, quality, relevance, and seniority of speakers was appreciated. A face-to-face event was welcomed, and Covid-safe measures worked well.

At its peak 90 were in attendance. 3 of the 5 sponsors have already committed to next year.

Interactive discussions with remote speakers were an issue but there is no obvious way to resolve this.

The venue and food rated as at least adequate, and mostly good.

There was some initial anxiety regarding having speakers from Sky Bet and Amazon but they followed the conference brief and proved popular conference slots.

11. Any Other Business

Alan Baker outlined the likely position re. membership fees and invoicing arrangements for 2022/23. An email will be sent to members following the imminent NYHDIF Management Committee. [ACTION: NYHDIF SUPPORT]

Dean Davidson updated the Forum on his work focus around 'What good looks like', especially in relation to how to support Trusts not yet at a minimum level to be able to implement an EPR. 44 Trusts currently don't have an EPR in place at the moment. This work will include what might be included in a minimum viable EPR product.

He is making the connection between other initiatives such as the Smart foundations assessment survey and the Digital Aspirant Plus work. Some slides will be circulated to Forum members. **[ACTION: NYHDIF SUPPORT]**

12. Virtual Wards: TytoCare: Use Cases, Jan 2022

Ellen Barnes, Programme Manager at the Y&H AHSN highlighted a number of local and varied case studies.

13 projects are running across WY&H. The essence is the use of remote care devices for remote examinations. There are lots of clear benefits for delivering care closer to home.

The product is cloud-based and can handle limited communications/internet outages. Within patient homes some patients have been provided with 4G connections.

ESR API Wrapper is Open-Source code and forms part of the 'Public Money, Public Code' approach

A number of questions were responded to including the quality of the CSV extract from ESR and an offer to look more closely at the local Y&H Acute environment.
